## Pennyroyal Juried Art Exhibition

Sponsored by Hopkinsville Art Guild will be held at Hopkinsville Community College Auditorium Building Art Gallery, 720 North Drive, Hopkinsville, Kentucky from Oct. 3 through Oct. 31, 2015.



### About the Juror:

Tuva Stephens, an award-winning competitive artist in the field of water colors will be the juror.

Tuva who lives in western Tennessee, has taught art and drama for 33 years at the high school level. Ms. Stephens is a National Award Winning Watercolor Artist. She recently displayed her artwork in Transparent Watercolor Society Exhibit, the Watercolor West International Exhibit and the Mississippi Grand National Display. Tuva holds a signature membership in the Kentucky, Missouri, Alabama, Tennessee and Southern Watercolor (18 states). She will serve as the Southern Watercolor President 2015-2017. Recently, Tuva's work was featured in the art literature magazine *Splash 15: Creative Solutions*.

### Categories

Artists may submit a total of **Two** works in the exhibition in any of these 5 categories:

- 1. Drawing:** (Pencil, Charcoal, Ink, Pastels)
- 2. Painting:** (Oil, Acrylic, Watercolor, Encaustic)
- 3. Mixed Media/Collage:** (Collage, Montage, Experimental)
- 4. 3-D/Fiber Arts:** (Cut paper, Pottery, Sculpture, Jewelry, Textiles, Baskets, Wood turning/carving, etc.)
- 5. Photography**

### Eligibility

Any visual artist residing in Kentucky or surrounding states may enter. All work must be original not under the guidance of an instructor. Work must be completed within the last three years, and not previously exhibited in the Pennyroyal Juried Art Exhibition.

### Entry Fee And Procedures

An artist may enter up to 2 works for the following non-refundable fee of \$20 for each work entered. Checks should be made payable to **HAG**.

### Delivery

Completed entry forms and fees must be delivered with the work either on Friday, Oct. 2 or *Saturday Oct. 3* between the hours of **9:00** a.m. and **NOON** to a Hopkinsville Art Guild member at the Hopkinsville Community College Auditorium Bldg. Art Gallery, 720 North Drive, Hopkinsville, Kentucky. **No early work or late work will be accepted as there will not be anyone from the Hopkinsville Art Guild there to accept them.** Hopkinsville Community College employees are not associated with the art exhibition.

### Framing And Limitations

All **two-dimensional work** must be strongly framed, securely wired, ready for hanging, and weigh no more than 40 pounds. Saw-tooth hangers will not be accepted. Sculpture and other **three-dimensional art** may not weigh more than 40 pounds. Freestanding sculptures requiring special mounting are not accepted. Top heavy or unstable work will be disqualified. **Needle Work** must be original design and hand done.

### Awards

This show will be juried for awards. Cash awards will be given for Best of Show, and First, Second, and Third Place in each category. Honorable Mention ribbons may be given at the discretion of the juror. The amount of awards will be based on entry fee receipts and sponsorships.

### Insurance

Signature on entry form constitutes agreement by the entrant that there shall be no liability on the part of the Hopkinsville Art Guild or any members or sponsors for loss, damage, or destruction of any works. Insurance of artwork is the sole responsibility of the participating entrant.

### Sales

Sales must be arranged between the artist and the buyer. No commissions will be charged. All work must have a price listed for insurance calculations even if the work is not for sale.
