A motion was made at the request of the Treasurer by Henrietta Kemp and seconded by Beverly Atwood, to merge the sales tax account with the regular checking account. Motion passed. The sale of H is for Hopkinsville and Christian County Counts books was discussed. It was decided to charge sales tax on any books that are sold through credit card purchases. Book sales that are cash and check sales will be collected and put in an envelope in the cash box for the Guild treasurer to deposit.
