Financial Report: Treasurer Janice Cayce presented the financial report for July. She reported we have a bank balance of \$3,463.35 as of July 31, 2012. A motion to approve the report was made by Betty Liles and seconded by Guy Bozard. Motion carried.

Membership: Betty Liles reported we currently have 75 members.

Gallery/Studio Committee:

Facility oversight committee— Lynn Shepherd reported we had had an excessive water use in the Studio during the month and a plumber was called which cost \$71.00. HWEA was nice to reduce our \$150.00 bill to the normal rate of \$35.00.

Christmas Bazaar will begin November 23. Members may set up tables for sale of Christmas items if they wish. Those not currently exhibiting may do so as long as they agree to work 4 hours during the time the tables are up. We will once again reduce the commission on pieces sold from 25% to 10% on all items sold starting November 23 through December 23. It will be important that we are open extra hours during this month, therefore members are asked to notify Lynn Shepherd if they are available to work extra hours. Sunday opening is planned.

There will be two work sessions at the Studio to paint ornaments to sell in the Gallery for Guild fundraiser. They will be after the next 2 Guild meetings, September 13 and October 11. Members interested in helping with this should contact Betty Vinson.

The Guild will once again offer Christmas Cards for sale. John Hall has agreed to award a \$400.00 for the purchase award winner. Deadline for entry is September 29, 2012.
