Meeting was called to order by President Nancy Stalls at 12:00.

Minutes: Minutes from the Oct. 8 meeting were reviewed. Motion for approval made by Carolyn Self, seconded by Nada Fuqua, motion passed.

Membership report – Betty Liles announced we currently have 68 members.

Treasurer's report – Treasurer Carol Lewis reported our income from Oct. 8 through Nov. 11, 2009 of \$972.00 and expenses of \$5,645.66. The main expense being the \$4,650.00 in prizes awarded for the Pennyroyal Juried Art Exhibition. We currently have a checking account balance of \$9,427.60. A motion for acceptance of the financial report was made by Betty Liles and seconded by Carolyn Self. Motion passed. Artists present were given their commission checks for the October sales.

L&N Depot Gallery Committee – Judy Campbell reported there are no artists scheduled for the Depot Gallery. The hanging system will be left at the Depot until needed in the future.

PACI report – No report.

Mall Gallery report – Stalls, Campbell and Kemp will meet with the mall manager to discuss mall policy manual which was just received. Due to the current policy of allowing all members to exhibit a limited number of pieces in the gallery it will not be possible to have a juried exhibition in the gallery until July, 2010. Carolyn Self and Nancy Stalls will investigate the purchase of a small used refrigerator for use in the kitchen. Judy Campbell reported 2 pieces of Guy Koehne artwork are being donated for sale at the gallery by Ann Mabry.

Guild Christmas Cards - Sales are going well. Sale locations are the Guild Gallery, Gracious Me!, Staton Art and Framing, L&N Depot, and the Chamber of Commerce. There are only a few boxes remaining.

Christmas Bazaar – Nov. 27 and 28 - Postcards will be mailed as soon as the reprinted cards are received. The exhibit will be left up until January 1. There are 9 tables reserved to date. Nada Fuqua and Carolyn Self will provide hot spiced tea and cookies for the event. A press release has been sent out and the Convention and Visitors Bureau has the information on their web site.
