November 10, 2011

**Minutes:** October 13, 2011, minutes were reviewed and approved as read.

**Financial Report:** Janice Cayce, Treasurer, presented the report. We had income of \$1,628.95 during the month of October and expenses of \$2,181.28. We have a checking account balance of \$4,330.51.

#### **Gallery/Studio Committee:**

**Facility oversight committee**– Thanks to the donation of a light fixture from Cayce Mill Supply, Jim Mason and two friends hung the fixture in the Studio. Henrietta Kemp ordered and delivered the Walker hanging rod to the Studio and Jim Mason and Guy Bozard installed it in the studio.

Lynn Shepherd asked that members be careful with the use of paper towels. We are spending a lot of money purchasing so many.

Betty Liles reminded members we will begin the 10% commission charge on art sold in the Gallery as of November 21 through December 31. Extra tables will be placed in the Gallery during the Christmas Bazaar. They may set them up any time after the Art Auction.

Linda Pierce has volunteered to do decorative painting in the Restroom in the Studio.

Gallery Quarterly Change will be January 2 and 3, 2012.

**Publicity:** The newspaper ad for the Auction was in the Saturday, Nov. 5<sup>th</sup> Kentucky New Era for a cost of \$165.00. Signs have been put up in the Mall and around town advertising the event.
